


BOOK CLUB IN KINGSTON

Cynthia McCusker, junior high (7th grade) art teacher, has been selected for art residences in Italy, France, and Poland. She was awarded a partial scholarship for the residency in France where she participated in a performance painting at a live concert with over 2,000 people in attendance.

Her work was featured in juried exhibitions in Paris, France; Marnay-sur-Seine, France; Lancut, Poland; various locations throughout Poland as part of a traveling exhibition; Naples, Italy; Miami, FL; Tubac, Arizona; many galleries in the tristate area, including several in New York City.

Locally, Cynthia has participated in performance painting fundraisers for local non-profit organizations like Mid-Hudson Animal Aid and Howland Cultural Center; just completed a mural at a hair salon in Hyde Park; was the Artist in Residence for the Walkway Over the Hudson Opening Celebration; worked with community art-making efforts which involved WJHS students and many local

families including seniors; and made mosaic murals with village kids in the Village of Wappingers Falls (at Veterans Park).

GAYHEAD RAISES OVER \$40,000 DURING JUMP ROPE FOR HEART

Gayhead has raised our highest Jump Rope for Heart total ever, raising \$40,746.34 to help the American Heart Association fund research and education programs. On Valentine's Day, Mr. Sean Keenan, a 4th-grade teacher had his head shaved. The following classes attended the head shaving:

- -Ms. Schukal's (the 6th grade with the most participants at 45% and the most money \$1,820)
- -Mr. Kennedy's (the 5th grade with the most participants at 48% and the most money \$1,405)
- -Mrs. Colucci's (raised \$5,208 the most money in the whole school)
- -Mrs. Guerriero's and Mrs. Tortarella's class (with the most 4th grade participants at 52 %).

The Shavers for the day were the top two Gayhead fundraisers Aidan Downey (\$4,335) and Alycia Conti (\$1,220), and raffle winners (those who raised \$100 or more) Ella Corrao, Victoria Abt, and Mrs. Burger.

The top fundraising class in the whole school was Mrs. Colucci's 4th-grade class raising \$5,208. They will also earn a Heart Healthy luncheon in the Spring. The Top participating class with 74% participation was Mrs. Carroll's 1st-grade class. They will earn a Recess Equipment Package.

Quote from Mr. Sean Keenan, 4th-grade teacher: "There are a couple of reasons I volunteered to have my head shaved. Most importantly, The American Heart Association does an unbelievable job for a GREAT cause!! My good friends Mr. Piggott, Mrs. Boccini, and Mr. Russo, are highly motivated physical education teachers who take on the enormous task for the benefit of the charity and I thought shaving my head could help raise more money.

Another reason is Norm Schofield, who the charity drive honors. I went to Our Lady of Lourdes with some of his



children. They are a great family who are pillars of the community. Doing things for other people is one of the Core Values we learned at Lourdes. So, I figured if getting my head shaved would help raise a little more money, it would be well worth it.

Over the last two years, three John Jay High School Alumni - Nolan Kartholl, John McMahon, and Mitri Najjar – combined their passion for business acumen to create the Educ845 Foundation. Recognizing an opportunity to offer experiential business learning to high school students, Educ845 seeks to create the next generation of conscience, analytical problem solvers and students who can accelerate their ability to make an impact by hosting innovation scholarship competitions.

The competitions, which run throughout the school year, enable groups of two to four high school seniors to compete for a \$5,000 college scholarship. Their task: Create a solution that im-

Our hearts are broken. It is impossible to make sense of the mass shooting at Marjory Stoneman Douglas High School in Broward County, Florida. But in moments of tragedy, our union family comes together to support one another—and we ask you to join us.

Dear DEHIC Participants:

This is to inform you of an important update from the DEHIC Board of Trustees that will positively impact the prescription drug benefit of the Alternate PPO, Healthy Advantage PPO and EPO Select 20 beginning July 1, 2018. This important update is estimated to save the health plan \$2.2M over the next plan year.

During the Board of Trustee's meeting held on January 24, 2018, a motion was made to approve the introduction of Mandatory Mail Order Coverage for prescription drug maintenance medications.

By definition, maintenance medications are those drugs used to treat chronic, long-term conditions taken on a regular, recurring basis. Examples of chronic conditions requiring this type of treatment include diabetes, high blood pressure, high cholesterol, etc. DEHIC members currently have an opportunity to obtain their maintenance medication through the mail order process under Express Scripts, Inc. (ESI). The process is currently voluntary, and members are able to obtain a 90-day supply for two copayments.

Beginning on July 1, 2018, members will be required to obtain their maintenance medications through ESI, which will save time and money (two copayments for 90-day supply remains in place). No longer will they need to make a trip to the pharmacy, as the medication will be delivered directly to their home address. If members will be away from home for extended periods (e.g., 3 months or more), the medication can easily be re-directed upon request.

We have attached materials for your review that explain the process for you as well as a list of maintenance medications. The attached list of medications is subject to change by ESI, so it is important to periodically check with Empire customer service on such updates.

Although this does not go into effect until July 1, 2018, please enroll sooner than later so that any issues that may arise can be worked out. To ease in the transition beginning July 1, 2018, members will be allowed to obtain two prescription fills at their pharmacy if they have forgotten to enroll in the mail order service. After that, they must use the mail order service, or will have to pay the full cost of the prescription out of pocket. Should members forget to use the mail order service beginning July 1st, a letter will be sent to the member from ESI within 2 weeks after each fill at the pharmacy. The letter will remind the member to use mail order, as well as the ways in which they can sign up. A phone number will be included for additional member support.

Please take the time to review your medications and check the list to see what maintenance drugs are covered. Remember this will be mandatory as of July 1, 2018.

16 February 2011—All public schools in Milwaukee and Madison, Wisc., are closed as teachers call in sick to protest Gov. Scott Walker's plans to gut their collective bargaining rights.

19 February 1975—The U.S. Supreme Court decides in favor of sales clerk Leura Collins and her union, the Retail Clerks, in NLRB v. J. Weingarten Inc.—the case establishing that workers have a right to request the presence of their union steward if they believe they are to be disciplined for a workplace infraction.

Weingarten Rights: Read word for word to your supervisor. "If this discussion, meeting or telephone call could in any way be related to my being disciplined or terminated or affect any of my working conditions, I exercise my federal rights and hereby request that my union representative or shop steward be present. Without their presence, I choose not to participate in this discussion or meeting. Please do not request that I waive this right."
